The ministry is guided by a volunteer Board of Directors, who are representative of our area. The ministry at Camp Buckeye receives its support from local individuals, churches, and businesses.

The camp owns 92 acres of land and sits adjacent to the Beach City Wildlife area of 1900 acres. Camp Buckeye is located in the northwest corner of Tuscarawas County, within hiking distance of the beautiful Dundee Falls.
